ABSENTEE VOTING INFORMATION
NOVEMBER 7, 2017 MUNICIPAL ELECTION

- The application form to request a civilian absentee ballot can be obtained in the following ways:
 - a. Print the application from the Voter Registration webpage at www.clintoncountypa.com and mail the application form to Clinton County Voter Registration, 232 East Main Street, Lock Haven, PA, 17745
 - b. Apply in person at the Voter Registration Office, 3rd floor, 232 East Main Street, Lock Haven, PA 17745. Business hours are Monday Tuesday Wednesday Friday 8:00 am – 5:00 pm and Wednesday 8:00 am – 12:30 pm
 - c. Contact the Voter Registration Office at 570-893-4019 to request that an application be mailed to you.
- The first day to apply for a civilian absentee ballot is Monday, September 18. Applications received before this date will be held in our office until they can be processed. This office cannot transmit absentee balloting materials until the ballot is finalized, so those who apply for a civilian absentee ballot early should not expect to receive their absentee balloting materials immediately.
- The Last Day to apply for a civilian absentee ballot is Tuesday, October 31. Applications must be received in the Office of Voter Services before 5:00 pm in order to be processed. Faxed or emailed applications cannot be accepted. Postmarks do not count. When submitting an application by mail, allow at least 2 days for delivery of local mail and 3-5 days for mail originating from outside the county.
- The Last Day to return a voted civilian absentee ballot is Friday, November 3. Voted absentee ballots must be received in the Office of Voter Services before 5:00 pm in order for the ballot to be counted. Postmarks do not count. When submitting a voted absentee ballot by mail, allow at least 2 days for delivery of local mail and 3-5 days for mail originating from outside the county. Due to the weight and thickness of absentee ballot cardstock, additional postage may be required.
- Civilians who experience an emergency after 5:00 pm on Tuesday, October 31 may be eligible to apply for an emergency civilian absentee ballot. Contact the Voter Registration Office for more information.
- Uniformed military and their dependents and overseas civilians apply for and submit absentee ballots in accordance with different requirements and deadlines. Contact the Voter Registration Office for more information.
